MINUTES

Full and timely notice of this meeting was provided pursuant to C.R.S. 24-6-402(2)(c).

- 1. **Call to Order and Pledge of Allegiance**: Mayor Eddy Balch called the meeting to order at 7:06pm. Trustees Tom Gibb, Jerra Garetson, and Lucinda Lull were present. Attorney Chris Mochulsky was present. Minutes taken by Clerk Sara Gibb.

- 3. Town Attorney Report\*\*: No report
- 4. Special Presentation: David Turner, Colorado Communications (to discuss internet options in Pitkin) Mr. Turner presented on his background. He has worked as a network engineer with a company out of Montrose and currently works to fill needs such as internet provision. Fiber is approximately \$2-5/foot and with Gunnison being 30 miles that price point is above what he thinks should be considered. Mr. Turner explained the process for getting internet from Gunnison to Pitkin and answered questions regarding various usage scenarios. Financial information was presented and discussed.

Trustee Tom Gibb asked about a discrepancy between 4 and 6 inches triggering a plow event (difference in RFP vs. Plowing Policy). Phil Duetsch, whose company provided plowing in 2019-2020, stated that because they bid in a lump sum, they plowed more than less and spent additional time clearing corners, etc.

Mayor Eddy Balch received communication from resident Chuck Kolinski regarding plowing concerns for health and safety. Mr. Kolinski reportedly expressed to Mayor Balch that an assessment for snow plowing would be well-received. Mayor Balch would like information on the website regarding the breakdown of a property tax bill so residents understand what is assessed to Pitkin vs.

There was discussion about how to prioritize the Town's streets (Main, State, River).

Trustee Tom Gibb asked if the County plans to cover Main, State, and River. Mayor Balch stated that the Town does not have the agreement back from the county. The Board plans to vote at the next meeting to allow Attorney Mochulsky time to review the policy.
